April-June 2006 ADLF Rates

The ADLF interest rates in effect for the quarter ending June 30, 2006 are 5.25% for deposits and 7.25% for loans. ADLF loans are charged interest at prime less 0.5% and savings accounts accrue interest at the discount rate less 0.5%. Both are adjusted quarterly based on the rates published on the last business day of the previous quarter. ADLF Loan Review Committee Meeting Dates

Meetings for 2006 are scheduled for June 14, August 7th, and October 23rd.

As parishes participate in the Legacy for Our Mission capital and endowment campaign, we anticipate an increase in the number of ADLF loan requests. Current ADLF policy requires that parishes have at least 50% of the cost of the project in ADLF deposit accounts and the other 50% in pledges to be considered for a loan. The ADLF subcommittee of the Archdiocesan Finance Council reviews <u>ALL</u> loan requests. Information on changing your computer to automatically adjust for Daylight Savings Time. Click on: Start, Settings, Control Panel (Some of you access this menu via: Start, Control Panel, Date Time Language and Regional Options) Click on "Date and Time" Click on the "Time Zone" tab Click on the drop-down box and choose "Eastern Time" instead of "Indiana East" Put a check-mark in "Automatically Adjust Clock for Daylight Savings Changes" Click "OK" Please Note: All appointments kept in Microsoft Outlook's calendar will automatically be moved ahead one hour from the dates of April 2nd through October 29th when adjusting the

endar will automatically be moved ahead one hour from the dates of April 2nd through October 29th when adjusting the time to observe Daylight Saving Time. You will have to manually adjust all existing appointments in Microsoft Outlook back one hour for them to be correct during this time frame.
