### **State Form NP-20**

Indiana law requires organizations to report annually to maintain their sales tax exemption by filing an annual financial report **Form NP-20**. This form is very brief and will be <u>due by November 15</u>, 2007. # **Change in Mass Stipend**

The Bishops of Indiana, have voted to raise the standard **Mass stipend to \$10.00** from the current \$5.00 offering. This will take effect in the Archdiocese of Indianapolis **October 1, 2007**.

Please note the increase to a \$10.00 stipend is effective **immediately** on an occasion when a person requests \$100.00 or more, to be given for Masses. For example if an individual left \$100 or more in their will devoted "for masses", the increased stipend would apply.

All stipends should be reported monthly and paid through central payroll (See Budget Guidelines *Appendix*. *A*).

# **HSA Lump Sum Payments**

In May, the Archdiocese announced that additional lump sum contributions will be made to employees' Health savings Accounts on September 1, 2007. Because September 1, 2007 falls on a Saturday, the contribution will be made on Friday, August 31, 2007. The contribution will be made on the same day as the regularly scheduled September 2007 monthly contribution. On Friday, August 31, 2007 participating employees will receive the following:

- Single = \$500.00 additional contribution plus \$41.67 regular monthly contribution.
- Family = \$1,000.00 additional contribution plus \$83.34 regular monthly contribution.
